DEWEY LETTER Sincere thanks are due to Professor Max Fisch, formerly of the University of Illinois, and Visiting Professor this year at the State University of New York at Buffalo, who has turned up Dewey's two-page holograph letter to him dated 17 February 1942 and who has graciously given it to the Dewey Collections at Southern Illinois University. Especially valuable in the letter are Dewey's comments on what Justice Holmes had said about his writings--"extracts of which," he wrote, "I have always cherished with more pride than anything else ever said about my writings."

QUERY ABOUT WARD From Professor Edward F. Shaughnessy of Mary Washington College of the University of Virginia comes a query about Dewey's references to Lester Frank Ward. Professor Shaughnessy is acquainted with Dewey's review of *THE PSYCHIC FACTORS OF CIVILIZATION* (to be published in Volume IV of *The Early Works of John Dewey, 1882-1898*), but has not been able to find additional material on Ward in Dewey's works. If any *Newsletter* reader remembers such material, we would be happy to relay it in the next issue.
